Sample Bequest Language:

SPECIFIC BEQUEST
I give, devise and bequeath unto the Civil War Trust, a tax-exempt, nonprofit organization currently located in Washington, DC, or its successor (s) in interest, the sum of \$ (or percentage% of my total probate/trust estate, or property described herein) in support of its efforts to preserve Revolutionary War and War of 1812 battlefields. This fund is to be used by the organization as it deems advisable.
RESIDUAL BEQUEST
I bequeath all the rest and residue of my estate/entire trust estate (or percentage% of the rest and residue of my estate/trust estate) to the Civil War Trust, which is tax-exempt non-profit organization, located in Washington, DC in support of its efforts to preserve Revolutionary War and War of 1812 battlefields. This fund is to be used by the organization as it deems advisable.
Please note that you may further target your gift to be used for a specific purpose, in which case you can add the words "This Fund is to be used by the organization for the following purposes (s):" If a contribution is to be targeted, please review it in consultation with Civil War Trust/Campaign 1776 officials to be certain that your wishes may be carried out.
